Profile of participants:

The seminar targets current KA2 Adult Education beneficiaries funded under the 2017 Call.

Themes and goals of the event:

The seminar aims to contribute to the evidence-based analysis of project results. It will do this by equipping participants with the skills to plan and implement impact assessment activities. Ultimately, this will improve the quality of the evidence base for Erasmus+.

The main objectives are:

- To help beneficiaries understand the concept of impact assessment.
- To train beneficiaries so that they are able to: identify their project impact and outcomes; develop suitable indicators, and; identify suitable data sources.
- To help beneficiaries use impact evidence in their dissemination by identifying relevant audiences, stakeholders and communication mechanisms.

The seminar will include a number of practical group exercises designed to familiarise participants with (i) the stages of the Impact+ Exercise and (ii) identifying and targeting relevant stakeholders.

Participants will not complete the Impact+ Exercise for their project. The seminar will provide them with the skills to facilitate a discussion and complete the Exercise with their project partners.

The seminar is part of our "Applied Research Methods" TCA project which is co-led by the Slovenian E&T NA.

Expected results:

• Improved understanding of the concept of impact assessment.





- Improved confidence in implementing project impact assessment.
- Opportunity to meet and build a network of peers interested in impact assessment.
- Better quality project impact assessment (i.e., clearer focus, better indicators, relevant data sources, robust evidence, targeted dissemination).

Cost:

Event fee: The event fee will be covered by the hosting agency and it will cover accommodation (2 nights) and meals during the activity.

Travel costs: SEPIE will contribute to the travel costs based on the table provided for TCAs. This financial support will be paid directly to the selected participant by SEPIE in compliance with the procedures established by this agency (see information on the SEPIE website).

Support for accommodation and meals not included in the activity programme: SEPIE will contribute to these costs based on the table provided for TCAs. This financial support (up to 2 travel days) will be paid directly to the selected participant by SEPIE in compliance with the procedures established by this agency (see information on the SEPIE website).

Support for participants with special needs: Applicants with special needs might apply for a reimbursement based on real costs. The reimbursement based on real costs will be granted only if it is clearly justified and requested in the application form, and once approved by the national agency (SEPIE). This financial support will be paid directly to the selected participant by SEPIE in compliance with the procedures established by this agency (see information on the SEPIE website). By choosing this option, the participant will renounce to a reimbursement based on unit costs.
