Profile of participants:

The seminars are aimed at policy makers (and support agencies), managers and practitioners who have a role in leading, managing, supporting and/or delivering guidance services in schools (secondary education- 12 to 19 years old). Previous experience and/or understanding of data gathering and evidence based practice in guidance services in schools is highly desirable.

Themes and goals of the event:

The aim of the seminars is to develop a transnational resource which will facilitate the development of evidence based guidance practice and the use of ICT in supporting school guidance quality assured practices. The development of the transnational resource will be informed by good practice.

During the seminar you will have the opportunity to learn from the experiences of others and to share your own experiences and practices in relation to evidence based practice in guidance services in schools. The seminar will provide opportunities for group discussion, interaction and reflection.

It is expected that the same participants will attend the two seminars.

Expected results:

It is envisaged that a resource will be developed as a result of discussions and knowledge sharing during the thematic seminars. This resource will:

- •Identify data gathering tools and methodologies that can be used to inform evidence based practice in school guidance services.
- Present a set of questions relating to data gathering on inputs, process and outputs.
- Present a framework for how the data can be collected online.





Programme of the event:

The first seminar will take place on the 7th September (9am-5pm) and on the 8th September (9am-1pm).

It is expected that participants will arrive on the 6th September for a relaxed get-together in the hotel at 7.30pm.

On the 8th September lunch will be provided after the seminar concludes at 1pm.

Cost:

Event fee: The event fee will be paid directly to the hosting agency by SEPIE and it will cover accommodation and meals during the activity.
