**Profile of participants:** school leaders and teachers (pupils' range 10-14) interested in the theme of the seminar and committed to develop Erasmus+ School Exchange partnerships.

# Themes and goals of the event:

*Inclusive education – a road to social inclusion* - the main aim of the seminar is to exchange "good practice" in the area of inclusive education/social inclusion, to discuss and share the understanding of social inclusion and related challenges, to establish networks and develop project ideas in given area.

### Reasoning:

All EU countries face increasing radicalisation tendencies. Inclusive education is considered to be a key mechanism of social inclusion and access to quality education is one of the most important preconditions of social inclusion.

Inclusive education can help to overcome poverty and exclusion – pupils from socially and/or economically disadvantaged environment have bigger chance to succeed after early intervention and assistance. It is inclusive education which offers more methods/tools for combating prejudice and xenophobia as well as the rise of extremist views.

Teachers are among the first ones to observe first signals of students/pupils radicalisation. That's why they should be equipped with skills which enable them to address such situation and provide general values to their students. "Peer learning" and direct exchange among the teachers at EU level may help to identify the best practices in given area.

**Expected results:** Participants will develop project ideas in School exchange partnerships and start preparing their project application during the contact seminar.





**Expected results:** Mutual exchange of knowledge, experiences and possibly also finding partners for future participation.

#### Cost:

**Event fee:** the hosting NA agency will cover the hosting costs (catering, conference arrangements and speaker fees).

**Travel costs:** SEPIE will contribute to the travel costs based on the table provided for TCAs. This financial support will be paid directly to the selected participant by SEPIE in compliance with the procedures established by this agency (see information on the SEPIE website).
